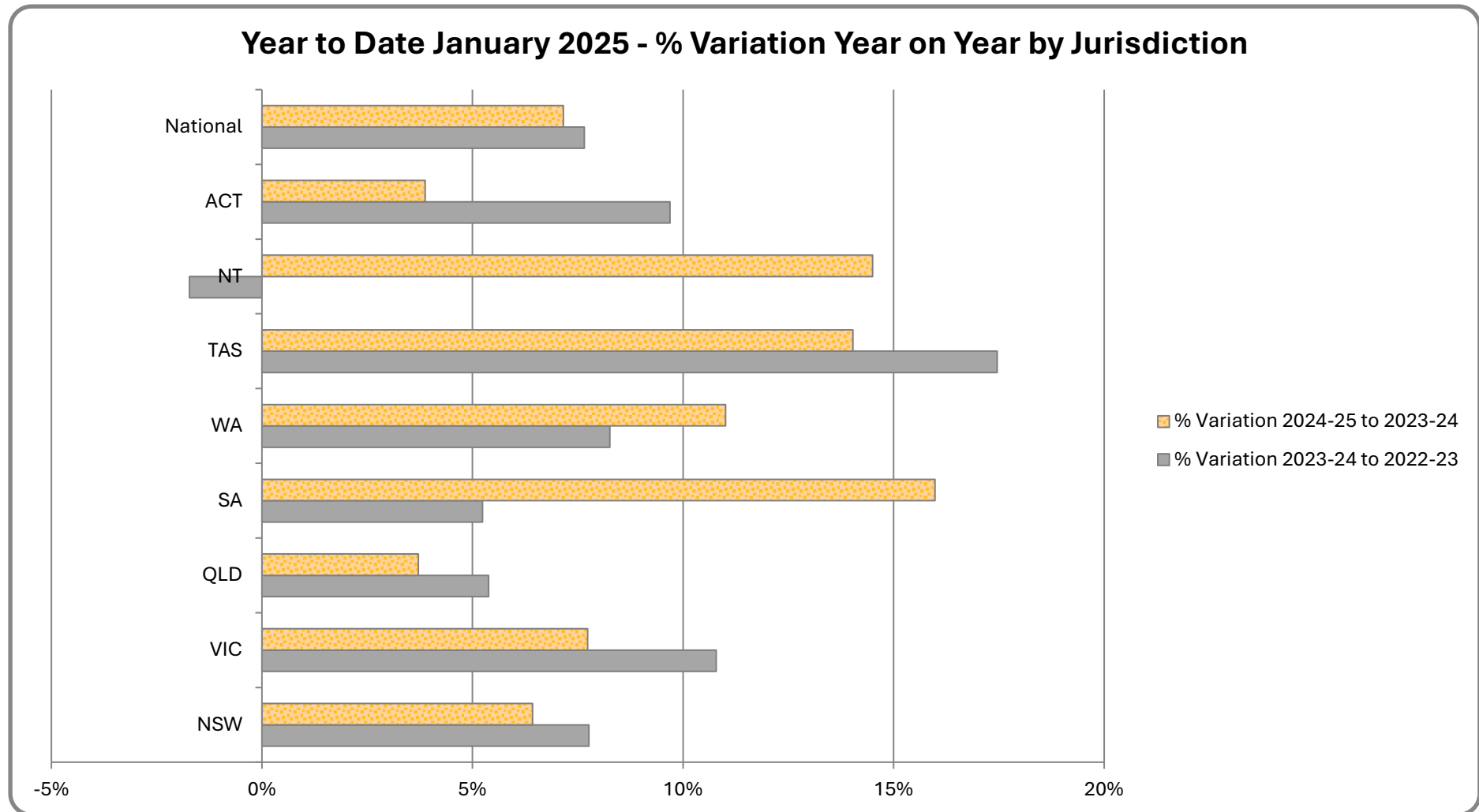

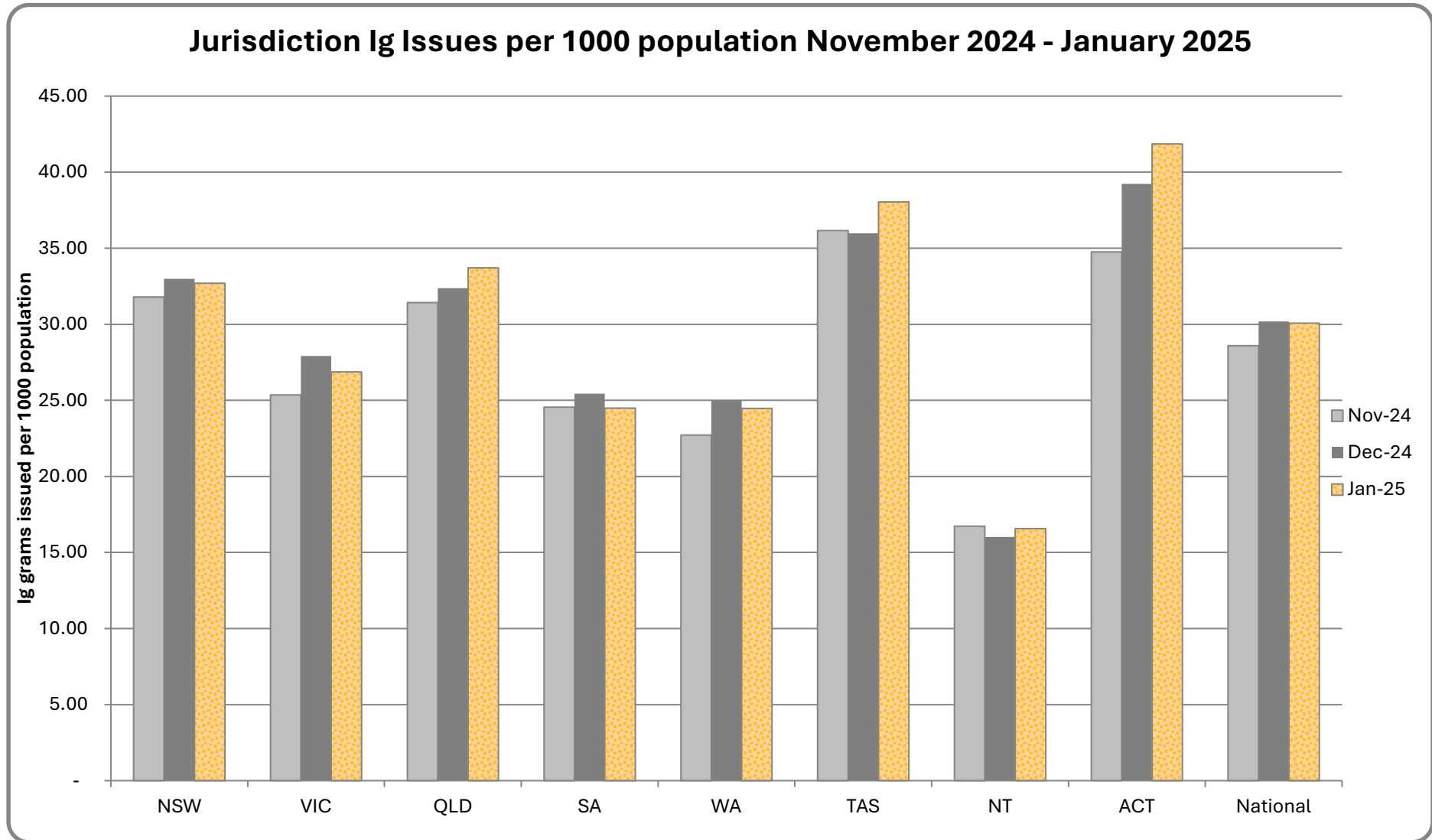
**Ig use**

**Year to date January 2025 - % variation year on year by jurisdiction.** This graph shows cumulative percentage changes in Ig issued, nationally and by jurisdiction, for the current financial year to date as compared to the same period in the previous financial year.



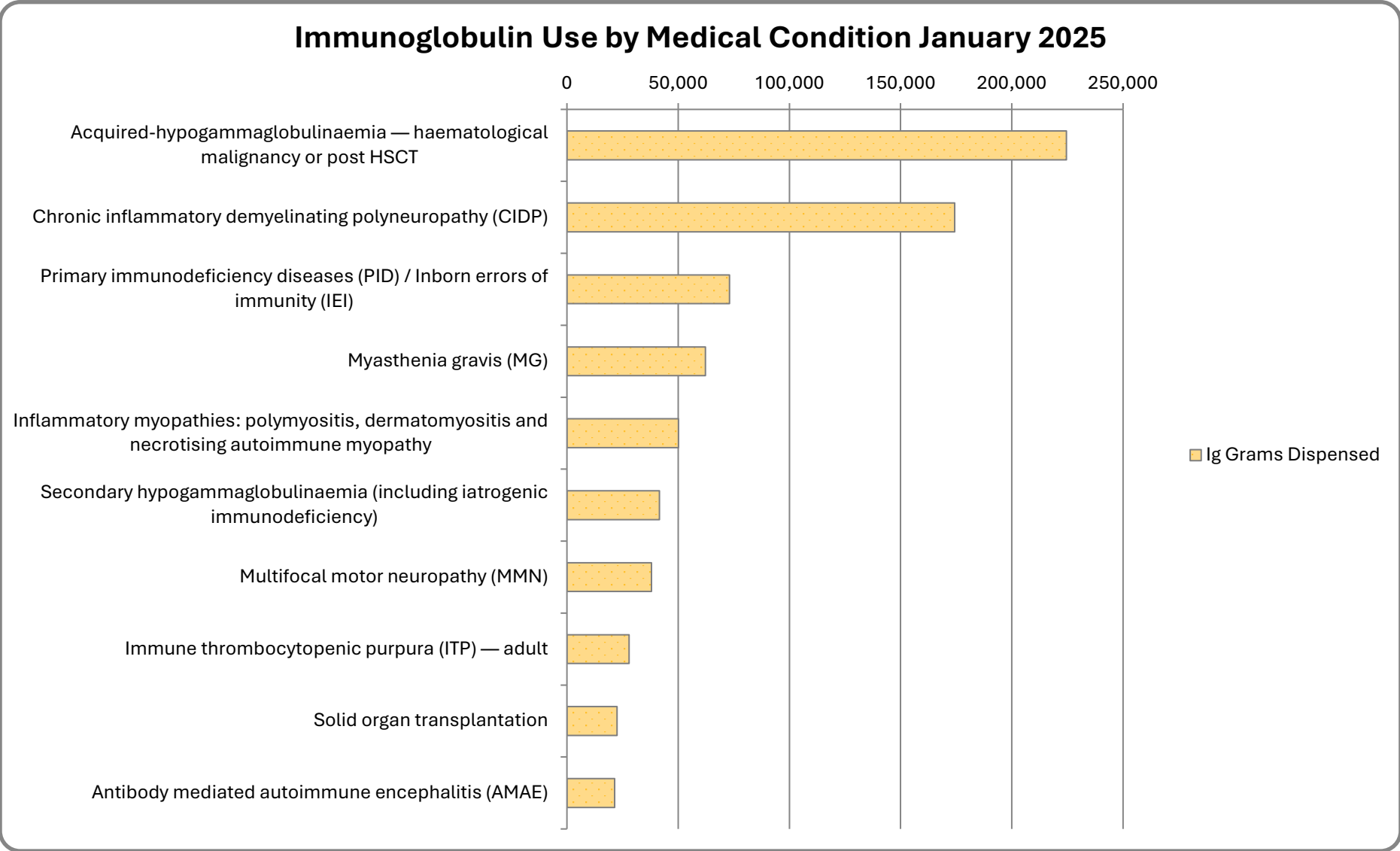

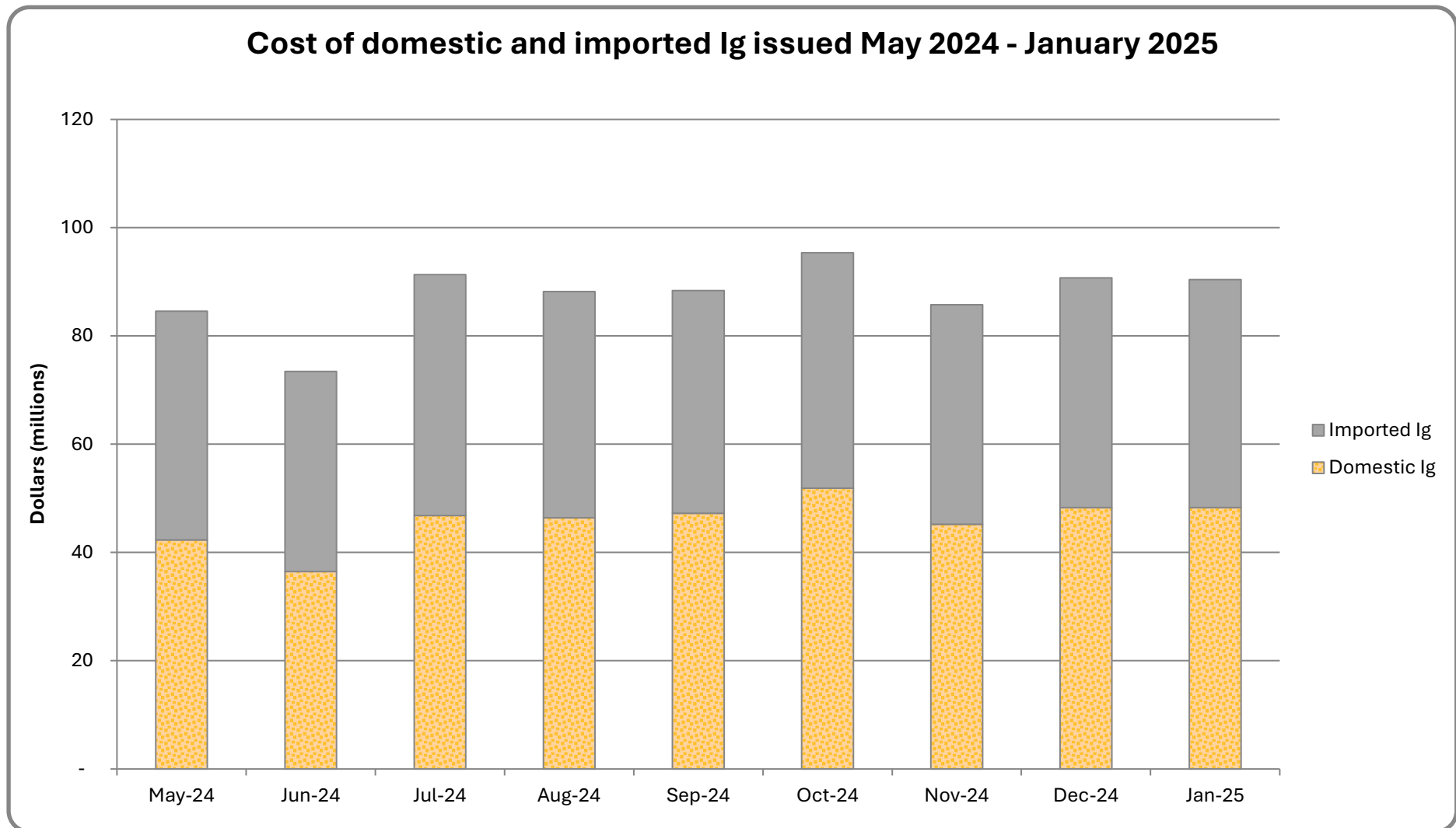

**Ig use by medical condition.** This graph shows the medical conditions which account for the highest use (grams dispensed) of Ig products.



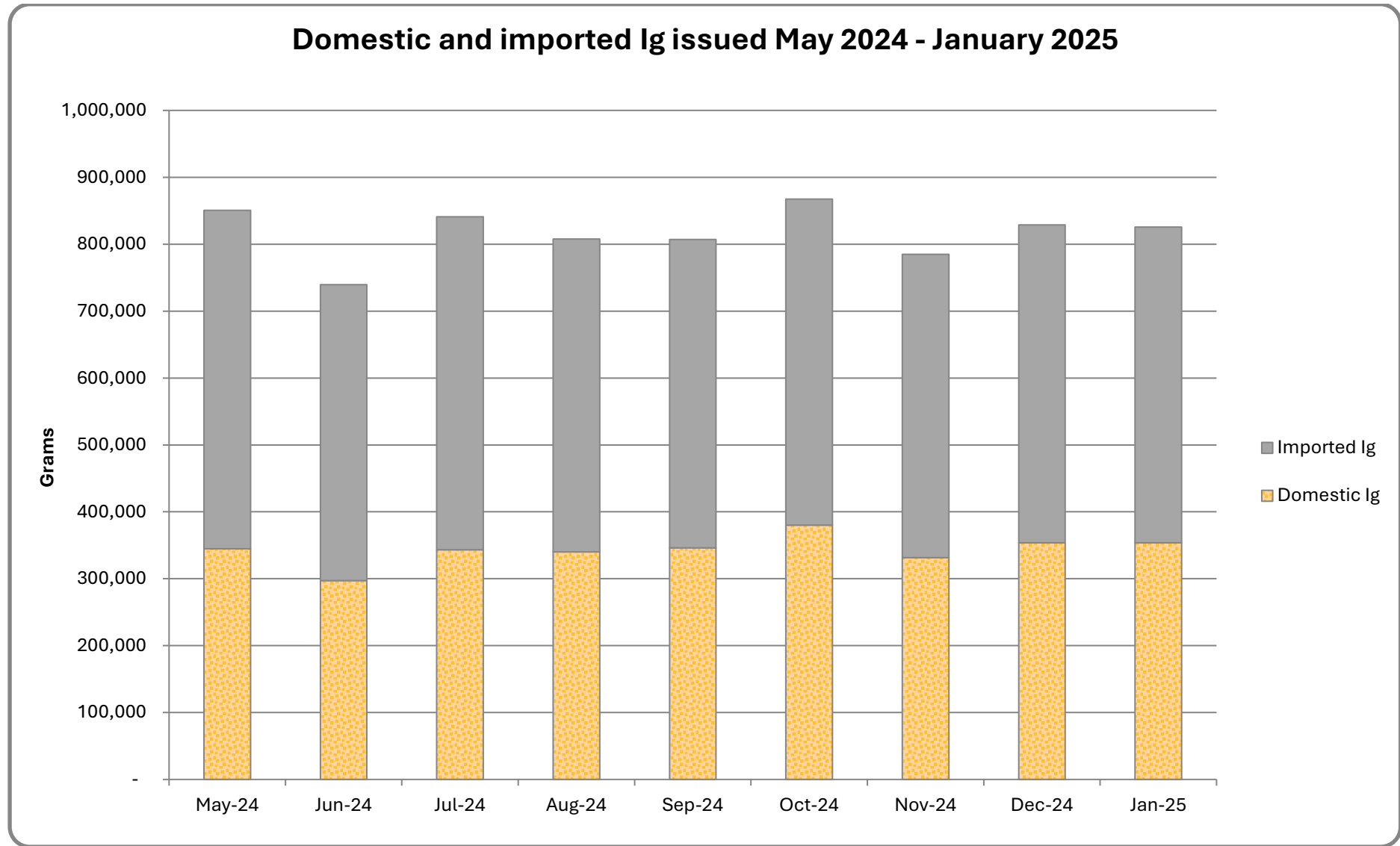

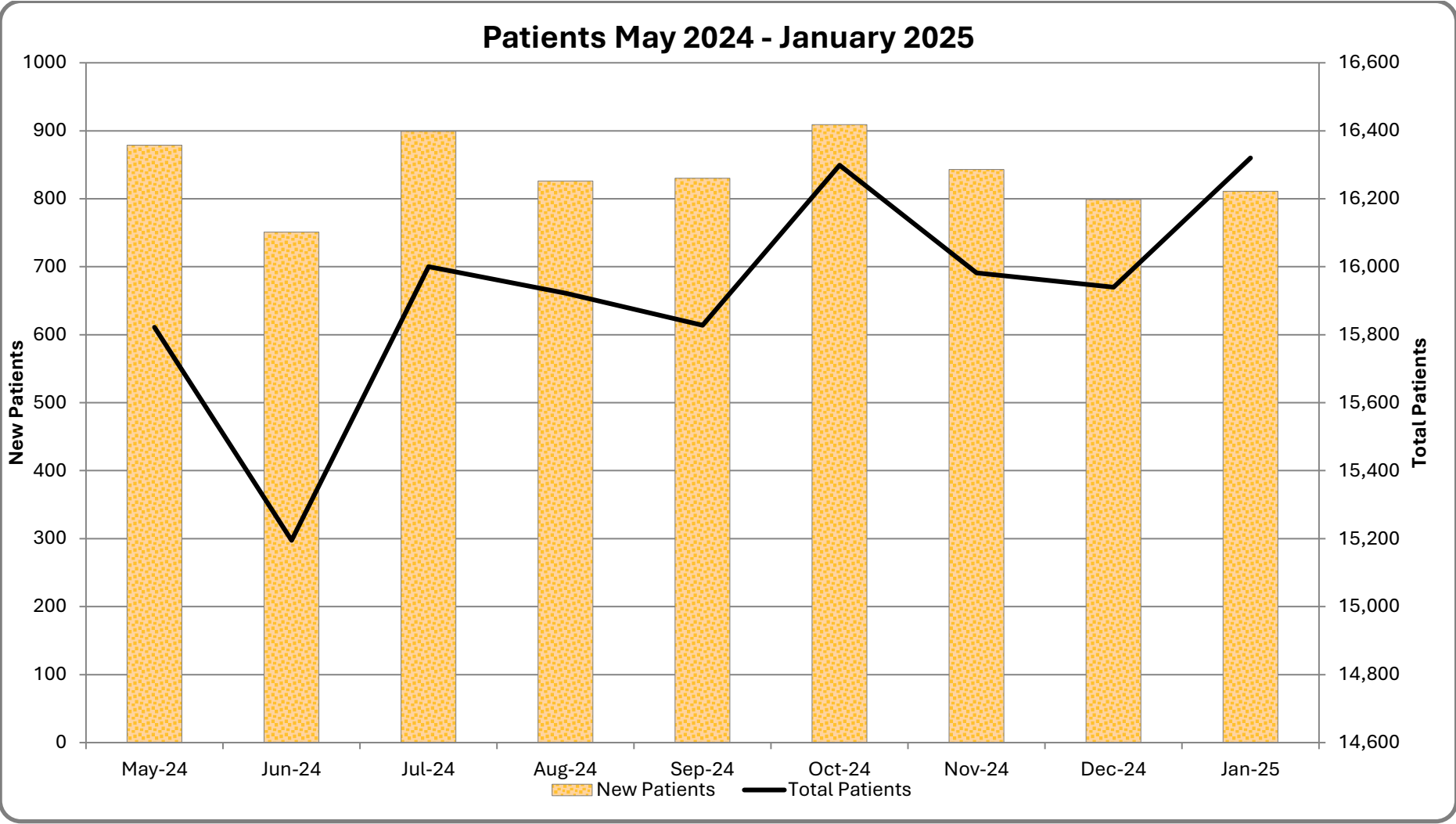
**Monthly usage of Ig.** This graph shows the amount of domestic and imported Ig products issued (grams) in the last 9 months.

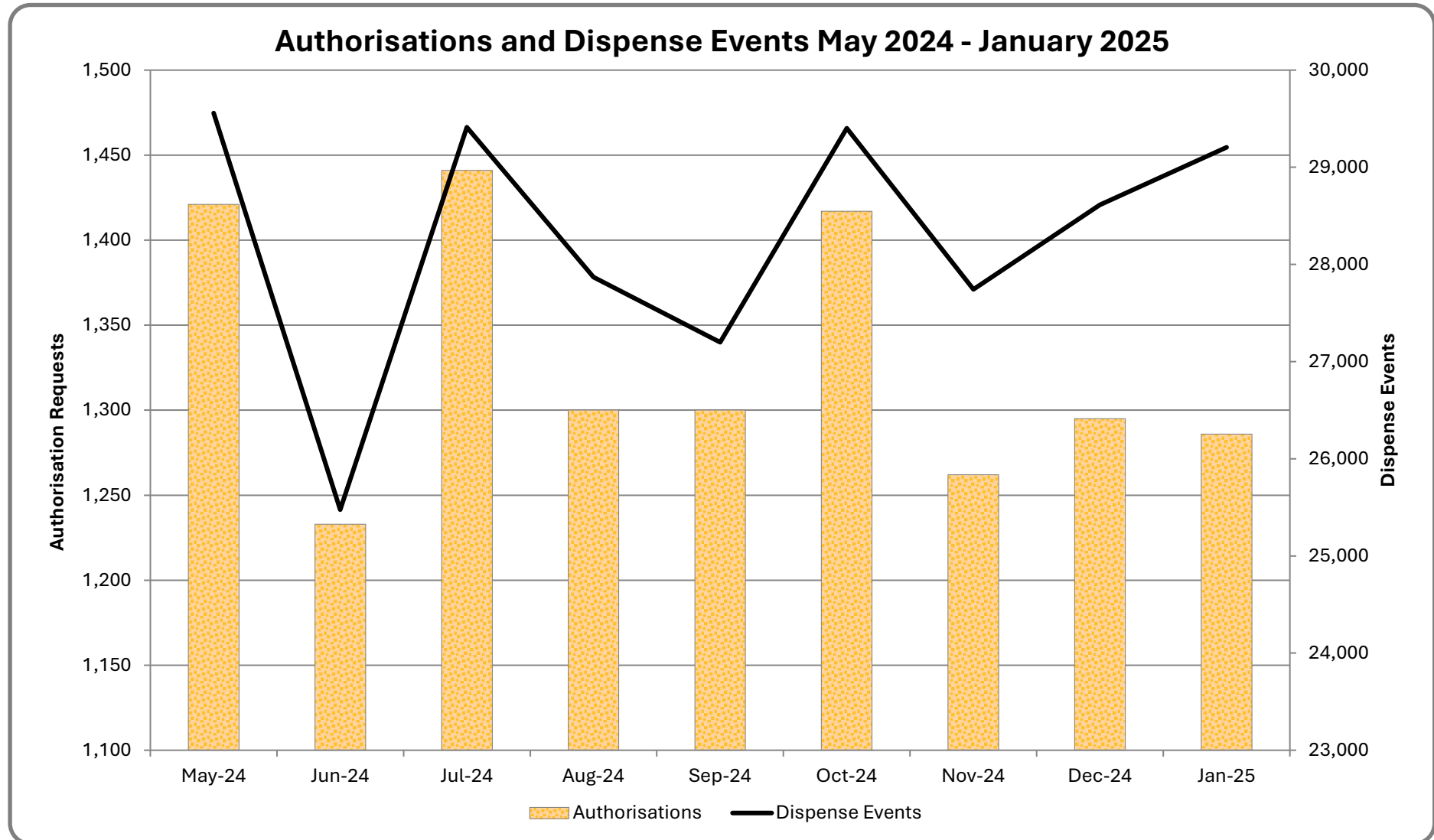
